This could be an overview that includes major initiatives and highlights that were proposed and executed throughout the program year.

The 2022 fiscal year marked the third year under the 2020-2024 Consolidated Plan. The priority needs established in the Consolidated Plan include non-housing community development, housing rehabilitation, and homelessness prevention. The strategic goals established are means to address the outstanding needs. The goals include public facility and infrastructure improvements, housing rehabilitation, public service assistance, economic development, and public service assistance specific to the planning, preparation for, and in response to the coronavirus pandemic. A total of \$303,796 was allocated to the City of Shawnee for fiscal year 2022.

During the 2022 program year, January 1, 2022 though December 31, 2022, a total of \$200,096.11 in CDBG funds were spent during the fiscal year. The funds utilized were from the City's 2020, 2021 and 2022 CDBG program year allocations.

Infrastructure Projects - \$158,185.45 (2020 funds)
Public Service Projects \$33,910.66 (2020-2022 funds)

In 2020, the City was awarded \$414,752 of CDBG Coronavirus (CDBG-CV) funds via the CARES Act. During 2022, a total of \$155,894.85 of CDBG-CV funds were expended.

Assess how the jurisdiction's use of funds, particularly CDBG, addresses the priorities and specific objectives identified in the plan, giving special attention to the highest priority activities identified.

The right three columns of Table 1, above, shows activities that were both obligated and undertaken during the 2022 fiscal year. Activities that have been obligated and completed within all of the Consolidated Plan fiscal years (2020-2022) are reported under the Strategic Plan columns. The data is reported as of December 31, 2022. The City of Shawnee allows prior year(s)' funding to rollover for use in following years as long as the there are no significant barriers preventing completion of the planned activities. The projects undertaken align with the Consolidated Plan priority needs and goals as addressed previously. All activities are considered high priority, so the City and subgrantees work diligently to ensure timely program implementation and completion.

There are a number of items that impact the progress for implementation of the five-year Consolidated Plan.

- As identified in Table 1, progress has been made toward meeting the Consolidated Plan goals and objectives in all areas, except for the
 housing rebhaiblitation program. There continues to be a significant backlog in the review of those projects to determine if they are elgible
 to recieive CDBG funds, specifically a backlog during the environmental reviews. City Staff is making progress on reviewing those projects.
- Infrastructure projects are annually the the biggest expenditure, and thus biggest barrier to aheiving timely expenditure of funds. For the
 first time since becoming an entitlement grantee, the City will be completing an infrastructure project in the same year as the funds were
 obligated. We would like to maintain this practice moving forward, but it may not be feasible based on staffing shortages and workload.
- The 'Other CARES Act' goal to provide public service activities other than low/,oderate income housing benefit over-estimated was created a broad projects goal with the majority of the monies not specifically identified for grantee projects. As such, this portion of funding and projected impact is likely over-estimated. At this time, the City has not identified any additional opportunities to utilize the

- remaining CDBG-CV funds.
- In 2023, staff will be completing a minor amendment to the 2020 Action Plan to reallocate CDG-CV funds from the Other- CARES ACT goal to the Economic Development grants for job retention/creation as the estimated funding was exceeded.
- As required by HUD, a CDBG Workout Plan has been created following delays in timely expenditure of CDBG funds. The Workout Plan identifies a number of barriers and actions to remedy further spending delays. One of the actionable steps includes employing additional and earlier subrecipient reporting to ease review backlog at the end of the fiscal year, and to stay informed of any delays that subrecipients are experiencing to determine if City staff assistance is needed.
- Since the end of the 2022 fiscal/calendar year, there has been additional activity completion and reporting that is not reflected in the 2022 CAPER document.
- There is a small amount of unprogrammed funds from FY 2019 due to an infrastructure project coming in under budget. These funds will be reallocated to the 2023 infrastructure project as identified in the 2023 Annual Action Plan to be submitted.

Narrative

Table 2 shows only persons served by activities proposed and undertaken within the 2022 program year, and does not include all race categories as reported. An additional thre (3) 'other multi-racial' were also served and not identified within the default reporting table. Activities in which funding was obligated prior to 2022 but not completed until 2022 are not included in the tables. The tables also do not include the demographic makeup of households benefitting from the infrastructure improvement project as the data does not exist.

The 2020 Decennial Census shows that ShawnEe has the following racial and ethnic demographics makeup:

White - 78.2%

Black or African American - 5.7%

Asian – 3.2%

American Indian or American Native – 0.5%

Other - 12.4%

Hispanic - 9.2%

Overall, the 2022 programs served more minority clients (appx. 59%) than the broad racial minority makeup of the community as a whole (appx. 22%). Approximately 33% of all persons served were Hispanic. Approximately 9% of the Shawnee population is Hispanic comparatively.

Narrative

Shawnee's 2022 CDBG entitlement grant award was \$303,796. Table 3 includes only FY2022 CDBG monies spent during the 2022 program year. In 2022, CDBG funds available from fiscal years 2020 and 2021 totaling \$196,118.11 were spent. A total of \$155,894.85 was expended of CDBG-CV funds, which were allocated in 2020.

Narrative

Shawnee does not areas of minority concentration for special funding. Generally, Shawnee prioritizes major infrastructure improvement projects through our 10-year Capital Improvements Program. The City has focused on complete street and stormwater improvements in a specific neighborhood over the last ten years, which CCDBG funds have been used to supplement many of the infrastructure projects. CDBG funds for infrastructure improvements are limited to census block groups in which 50% or more of the residents are low to moderate income. Minor home rehabilitation projects are open to income eligible residents throughout Shawnee. Public services are also open to income eligible Shawnee residents.

Leveraging

Explain how federal funds leveraged additional resources (private, state and local funds), including a description of how matching requirements were satisfied, as well as how any publicly owned land or property located within the jurisdiction that were used to address the needs identified in the plan.

The City of Shawnee operates under an agreement with Johnson County to be part of the Johnson County HOME Consortium for Federal Fiscal Year 2021-2024. The cooperative agreement designates Johnson County to receive and allocate HOME program funds, and stipulates a 25% City match. This program, along with CDBG funds, is used for lead based paint abatement and accessibility improvements as part of home rehabilitation projects.

Annually the City uses CDBG funds to supplement Capital Improvement Projects in our low-moderate income Census Block groups. Utilizing CDBG funds for infrastructure improvement projects allows the City to complete improvement projects that would otherwise not have adequate funding and/or funds can be allocated elsewhere to complete other needed projects.

The City does not have publicly owned land aside from parks, public facilities, and road right-of-way.

Discuss the difference between goals and outcomes and problems encountered in meeting these goals.

Generally, Shawnee CDBG activities undertaken address providing, acquiring, or producing affordable housing units. Activities are focused around providing economic assistance through public service activities that can help households maintain their housing and meet other immediate needs.

Subgrantee Friends of JCDS (FoJCDS) provides affordable housing to developmentally and intellectually disabled persons. The City allocated funding to FoJCDS in 2022 to support construction of a new single family residence for four special needs persons. The project is still in the design phase, but is expected to

be constructed in 2023. The provision of financial assistance to FoJCDS allows their organization to continue to create and maintain housing that is affordable to their clients.

The Minor Home Rehabilitation program does not specifically address affordability for owners, but can remediate problems with homes that are increasing expenses. An example would be replacing an HVAC system with an energy efficient system, which can lower energy bills, thus creating affordability for the homeowner.

Discuss how these outcomes will impact future annual action plans.

Shawnee annually allows allocated funds to rollover for all actitivites, thus allowing them to be spent beyond the designated program/calendar year, within reason. City staff will continue to work with all subrecipients to ensure that all actitivites are completed within a timely manner. Additionally, as part of the City's timeliness workout plan, Staff has created and is requiring additional intermediate reporting deadlines for subrecipients. This should help to identify any program delays and allow for more timely expenditure of funds in lieu of delaying until annual, year-end only reporting.

Review of past performance is part of the annual evaluation and rating for all CDBG subreicipient funding requests. Based upon the prior year outcomes and associated scoring, it is possible that recommendations for decreased funding can be made when developing annual action plans and obligating funds in order to more closely align with achievable project outcomes.

Narrative Information

Table 13 shows the number of low-moderate income households served in 2022 through low-moderate income clientele benefit programs. The data only includes activities funded and undertaken during the 2022 calendar/fiscal year. For FY2022, that means the table only includes data from one activity, Catholic Charities of Northeast Kansas' subsistence grants to LMI households. Additional low-moderate income assistance was provided to Shawnee households via actitivities that were funded in 2020 and 2021 but completed in 2022.

The median family income for Johnson County, Kansas in 2022 was \$97,700. Persons that received subsistence payments or financial assistance for child care services were required to meet the HUD income limit guidelines. Eligible persons cannot earn more than 80% of the median income based on household size. Each subrecipient is responsible for determining household income prior to committing CDBG funded assistance. City staff reviews all income determinations for consistency prior to authorizing reimbursement payments.

The City does not own public land aside from parks, public facilities and road right-of-way.

The City does allocates funds to subgrantees to provide subsistence payments to low-income households who might be at risk for losing their housing or losing access to critical utility services. It is anticipated that 10 persons at risk of becoming unhoused are served annually through the subsistence programs. Otherwise, CDBG funds typically are not used to address worst case or immediate needs. The Federal Emergency Solutions Grants (ESG) are targeted for and utilized by public service agencies within Johnson County and the KC metro. to specifically address worst case and emergency needs for all low-income households.

Additional information about how the City promotes, participates, and encourages the development and maintenance of affordable housing is included within this report is sections CR-25, CR-30, and CR-35.

CR-25 - Homeless and Other Special Needs 91.220(d, e); 91.320(d, e); 91.520(c)

Evaluate the jurisdiction's progress in meeting its specific objectives for reducing and ending homelessness through:

Reaching out to homeless persons (especially unsheltered persons) and assessing their individual needs

The City of Shawnee does not receive ESG funds, which are specifically targeted to assist people to quickly regain stability in permanent housing after experiencing a housing crisis and/or homelessness. Johnson County is the responsible entity in that regard.

Additionally, the Johnson County Continuum of Care on Homelessness, which includes more than 40 service providers, provides supports for transitional housing, rapid rehousing, and permanent supportive housing projects. The Continuum of Care on Homelessness conducts the required annual Point in Time count for all homeless persons in Johnson County. The Continuum of Care does not, nor does the City, track the "residence" of homeless persons in Johnson County, so it is difficult to speak to needs of homeless persons specific to Shawnee. Based on the Point in Time data and input from area public service agencies, there are several barriers to accessing safe and stable housing for all. These barriers include lack of stable employment history, poor credit or no credit, past due utilities, fixed incomes due to age or disability, low incomes, eviction history, and incarceration/criminal record. Opportunities from multiple funding sources and agencies within Shawnee, Johnson County and the Kansas City metro. do exist though to provide supports to overcome identified barriers. Unfortunately though, the need often outweighs the available resources.

The City of Shawnee provides CDBG funds for the Salvation Army, Metro Lutheran Ministry, and Catholic Charities for homelessness prevention in the form of emergency rent and utility assistance for Shawnee residents.

Addressing the emergency shelter and transitional housing needs of homeless persons

In 2021, the City of Shawnee amended our Zoning Regulations to be inclusive of homeless shelters, crisis shelters and emergency disaster shelters. The City's zoning regulations were unclear on all three use allowances prior. The amended regulations allow all three use types in all zoning districts, and establish minimum operational guidelines as well as life and safety requirements.

Civic and public service organizations within Johnson County continue to seek out ways to expand and strengthen housing options for persons experiencing homelessness. Current options are primarily for households with dependent children and are often not available for immediate housing. Immediate shelter is often arranged by diversion to a double up situation, through a system of one night hotel vouchers until shelter beds are available, or the household is accepted into a rapid re-housing program. Additionally, efforts are underway by multiple public service agencies within Johnson County and the

Johnson County Government to allocate funds to locate and construct a new emergency shelter for unhoused adults without children. A location has not been determined to date.

The Mid-America Regional Council was contracted to create a regional coordinate entry system (HMIS) that brings together prevention, diversion, and emergency permanent housing resources, incorporates service prioritization and offers individualized supports to stabilize homeless persons. The coordinated entry system is active and was adapted during 2020 to address changes in program delivery related to the COVID-19 pandemic. The Johnson County Continuum of Care will be transitioning the HMIS management to a new provider in 2023, since sufficient funding is no longer available for MARC to manage the system.

The City is not directly involved in the utilization of the coordinated entry system, since the City does not serve as a point of entry for residents and unhoused persons. We do refer persons needing public service assistance to a variety of agencies and resources, including Johnson County's My Resource Connection or the United Way.

As noted previously, county-wide ESG funds are available to provide funding for transitional housing.

Helping low-income individuals and families avoid becoming homeless, especially extremely low-income individuals and families and those who are: likely to become homeless after being discharged from publicly funded institutions and systems of care (such as health care facilities, mental health facilities, foster care and other youth facilities, and corrections programs and institutions); and, receiving assistance from public or private agencies that address housing, health, social services, employment, education, or youth needs

The Continuum of Care on Homelessness, including the lead agency United Community Services of Johnson County, has expanded efforts to track the trends and needs of young adults 18-24 years of age, also known as transitional age youths, in Johnson County. This age group has shown a high risk of experiencing poverty, especially those who age out of foster care, juvenile justice systems, experience homelessness, are diagnosed with mental health issues, are pregnant or parenting, or identify as LGBTQ. UCS facilitates the Tranistional Age Youth Planning Project to convene youth serving agencies to plan and implement system improvements. Shawnee supports those efforts.

In 2022, City of Shawnee CDBG funds were utilized to assist low-income individuals by funding various public services. This assistance alleviates some financial burdens and allows residents to focus on their housing needs. The Salvation Army, Catholic Charities of Northeast Kansas, and Metro Lutheran Ministry use their funds to provide emergency assistance to low-moderate income Shawnee residents. Low income residents were assisted through rent or utility emergency assistance.

Shawnee also seeks to support the immediate needs of homeless persons by providing City general funds annually to Shawnee Community Services (a local food pantry and assistance resource organization).

Helping homeless persons (especially chronically homeless individuals and families, families

with children, veterans and their families, and unaccompanied youth) make the transition to permanent housing and independent living, including shortening the period of time that individuals and families experience homelessness, facilitating access for homeless individuals and families to affordable housing units, and preventing individuals and families who were recently homeless from becoming homeless again

Members of City staff participate in the Continuum of Care on Homelessnes and seve on the CoC board, with United Community Services serving as the lead agency. Input assists in the selection and identification of needs when allocating funding to serve these needs. United Community Services maintains a wealth of information and are the experts to furnish agencies with the ability to provide programming for homeless, near homeless and at-risk persons. Coordination in these efforts results in the most efficient allocation of financial resources.

The City of Shawnee does not receive ESG funds since we participate in the Johnson County Consortium. The County is aware of the opportunites that may arise to receive state funding for ESG related programs.

Since Shawnee does not own or operate any housing facilities, it is nearly impossible to affect the private housing market due to preemption laws in the State of Kansas. Opportunities do exist though to provide supports or incentives to overcome identified barriers.

CR-30 - Public Housing 91.220(h); 91.320(j)

Actions taken to address the needs of public housing

The Johnson County Housing Authority provides public housing vouchers for residents and future residents of Shawnee. Our citizens utilize these resources to meet their housing needs if they are available. The City and County have defined roles in the provision of services to our residents. Services such as public health and mental health are provided funding by a county mill levy. The City has allocated funding in its General Fund to service agencies to provide specialized services.

Actions taken to encourage public housing residents to become more involved in management and participate in homeownership

The Johnson County Housing Authority (JCHA) continues to interact with participants of the Houusing Choice Vocher (HCV) program and other programs to expose residets to various homeownership opportunities, informational workshops, social service providers and other resources. Additionally, JCHA has various partnerships with service providers and financial institutions to help break down barriers that face their clients. JHCA also works with landlords to update them on HCV program guidelines and is a main source of communitication for landlords who operate HCV units.

Actions taken to provide assistance to troubled PHAs

The Johnson County Housing Authority is not a troubled agency. The City is not aware of any troubled PHAs in the area. The Johnson County Housing Authority consistently provides high quality services.

Actions taken to remove or ameliorate the negative effects of public policies that serve as barriers to affordable housing such as land use controls, tax policies affecting land, zoning ordinances, building codes, fees and charges, growth limitations, and policies affecting the return on residential investment. 91.220 (j); 91.320 (i)

In 2021, the City went through an update of our Comprehensive Plan. The new Comprehensive Plan builds upon and brings together existing planning efforts to create a unified vision for the future of Shawnee. The Comprehensive Plan demonstrates a path forward — using both physical and policy recommendations. The Comprehensive Plan addresses a wide variety of topics critical to the continued and improved success of Shawnee, and is supported by six guiding principles, including:

- Sustainable and Resilient Community,
- Strong Neigbhorhoods,
- Lively Spaces,
- Healthy Lifestyles,
- Connected Community, and
- Vibrant Economy

Each principle is supported by goals and policies to articulate steps the City will need to take to move in the preferred direction. The goals and principles outlined in the Comprehensive Plan a number of policies related to affordable housing, land use controls, zoning, sustainability, resiliency, building and property maintenance codes, mobility and multi-modal transporation, social equity, and access to health and human services.

Since adoption of the Comprehensive Plan, the City has put a greater focus on keeping the guiding principles in the forefront to make sure projects, budgets, transporation, resource allocation, and similar are consistent with the guiding principles of the Comprehensive Plan and the City's Strategic Plan.

In 2022, the City initated renewal of the 10-year the Kansas Neighborhood Revitalization Act, which makes tax rebates available to property owners who make improvements to their properties. The program encourages property owners to make improvements to their properties, as well as to provide in-fill housing in older neighborhoods. The new plan expands the eligible areas to a significant number of residential households, incuding areas with at least 50% LMI households, and an identified Environmental Justice area within Shawnee.

The City will also continue to consider the use of revenue bonds and other incentive mechanisms to help financing affordable housing in appropriate locations. The City continues to enter into Excise Tax Abatement agreements for residential and commercial development to encourage development and construction acitivities. Updated policy to approve abate of all requests.

The City enforces housing and Building Code requirements to assure all units are in safe and sanitary conditions. Print and digital resources are maintained for the public regarding housing discrimination, and information regarding fair housing is posted on the City website. The City has coordinated with Johnson County and other Johnson County cities to provide consistent fair housing messsging and resources across our region.

The provision of economic inventives to encourage businesses to locate and expand in the community through the economic development fund revenue stream will provide the city with a financial ability to grow it's economic base.

Actions taken to address obstacles to meeting underserved needs. 91.220(k); 91.320(j)

Each year the Shawnee City Council allocates General Fund monies to public service agencies to provide services for underserved needs within our community. In 2022, the City Shawnee provided \$30,00 to United Community Services (UCS) in 2022, a funding increase from prior years. Programs funded by UCS reach a wide variety of agencies that address homeless, at risk persons, as well as residents that are moving into permanent housing. \$30,000 was allocated for the Johnson County Utility Assistance Program (a \$10,000 increase from 2021), and newly obligated funds for rent assistance in the amount of \$10,000. \$26,000 (increase of \$2,000 from 2021) was allocated to Shawnee Community Services, a local food pantry and community assistance organization. \$10,000 was allocated to Rebuilding Together Shawnee, a local non-profit who performs housing repair projects in Shawnee for residents in need. They specifically target veteran and senior homeowners. \$2,500 was provided to the Special Olympics Shawnee.

City General Funds were also used to provide a rebate of franchise fees paid on specific utility and telephone bills, and for the City's annual stormwater fee for seniors and low income households. Additionally, up to \$1,200 is available during a 12-month period to Shawnee residents for financial assistance to offset Shawnee Parks and Recreation registration cost of classes, programs and memberships. The City also offers subsidized taxi services (CityRide program) in the City limits and three other designated locations for Shawnee residents 65 years of age or older or persons with disabilities.

In 2022, one-time ARPA grant monies were allocated to provide property tax rebates to seniors and low income owner-occupies households.

Actions taken to reduce lead-based paint hazards. 91.220(k); 91.320(j)

In following with HUD's Lead-Based Paint Regulations, the City enters into an agreement with Johnson County Housing Services to provide assessment of and remediation of lead paint, as warranted, in any Shawnee home that falls within the Minor Home Rehabilitation Program. The County has staff trained in Lead Safe Practices certified as lead-based paint inspectors and risk assessors, along with several contractors certified as lead-based abatement supervisors and certified lead based paint workers.

Lead paint issues most likely would arise in the Minor Home Repair Program, which is administered by

Johnson County Housing Services. The terms and conditions established in the City's service agreement with the County for these programs requires all projects to comply with lead based paint safe work practices and remiditation regulations when necessary. The lead-based paint testing and remediation exprenses may be incorporated in the program expenses. Additionally, HOME funds can be used for lead paint testing and remediation.

Aside from lead paint remediation available through the MHR and HOME programs, Shawnee does not offer any other testing or remediation resources. Shawnee has informational brochures in English and Spanish at City Hall, specifically available in the Community Development where residents obtain building permits.

Actions taken to reduce the number of poverty-level families. 91.220(k); 91.320(j)

The City recognizes a need to continue their current programs for lower-income families and to explore the opportunities to improve programs serving this segment of our community.

- The City recognizes one of the best ways to assist people in improving their economic position is
 to provide employment opportunities. Therefore, the City, through its policies and planning, will
 continue to encourage business growth in our community.
- The City will continue to be open to expanding services for lower-income people who are employed. For example, the City will continue to support grants for summer day camp and childcare scholarships. The scholarships will serve to support the work force within our City.
- The City plans to continue its efforts to support programs to maintain the quality and integrity of
 our older neighborhoods where the older, smaller and less expensive housing is found. The direct
 benefit to homeowners is the maintenance of property values and protection of their equity. The
 City actively supports infrastructure improvements and a neighborhood conservation program in
 these areas.
- The City also will continue to support the Johnson County Minor Home Rehabilitation Program for low to moderate-income households. These programs help maintain the quality of our housing stock, assisting primarily the elderly and disabled residents.
- The City supports an active property codes enforcement program throughout the City. In recognition that some families cannot afford to correct code violations, the City provides financial assistance or volunteer assistance to help eligible homeowners correct the property deficiency.
- The City will continue to provide information to the non-profit sector regarding federal, state, and city programs which would facilitate the development of programs to alleviate poverty or housing conditions.
- The City wil continue to work with other non-profit and public service agencies to support and publicize the opportunities for assistance.

The extent to which any of these strategies will directly reduce poverty is unknown. However, each strategy serves to ease, if not improve an individual's or family's living or housing conditions.

Actions taken to develop institutional structure. 91.220(k); 91.320(j)

The City of Shawnee's Community Development Department is currently responsible for CDBG program administration by authority from the Governing Body. CDBG funded projects are carried out by City staff, Johnson County Housing Services, and other subrecipients.

Actions taken to enhance coordination between public and private housing and social service agencies. 91.220(k); 91.320(j)

Through the Continuum of Care on Homelessness, and the City's support of their efforts coordination of benefits will continue to occur. The ongoing relationship between the City of Shawnee and United Community Services will assist in the identification of changing needs in Johnson County, and identify areas where financial assistance should be targeted as a shift in the service needs occurs. The City will continue to support various public service agencies, both public and private, with City General Funds, CDBG funding, and with other staff time and resources as available.

Identify actions taken to overcome the effects of any impediments identified in the jurisdictions analysis of impediments to fair housing choice. 91.520(a)

In 2019, Shawnee worked with the Johnson County Consortia members to review and update the 2011 Analysis of Impediments (AI) to Fair Housing as a preemption to the 2021-2024 Consolidated Plan. Specific impediments reported in the 2011 AI were addressed in the update. As part of the update, the Consortia updated our websites to provide consistent, standardized Fair Housing information. Additionally, non-Consortia communities in Johnson County were also invited and encouraged to participate by including the same standardized information on their website.

Following a region-wide and county-wide housing affordability studies, the Mid-America Regional Council has taken the lead on bringing local leaders and stakeholders to identify a collaborative path forward that addresses regional housing challenges and possible solutions that were highlighted in each of those studies. MARC has hired a Housing Program Manager, created a Regional Housing Partnership Strategy Committee, and is investigating the use of a housing locator tool for the KC region. City staff has been participating in these discussions and continues to pursue opportuntiies to create and preserve affordable housing.

CR-40 - Monitoring 91.220 and 91.230

Describe the standards and procedures used to monitor activities carried out in furtherance of the plan and used to ensure long-term compliance with requirements of the programs involved, including minority business outreach and the comprehensive planning requirements

The City of Shawnee maintains all project files, rules and procedures applicable to all CDBG projects. Relevant program information is shared with sub-recipients at the beginning of each award and throughout the process to final completion of annual programs and projects.

All acitivities receive desk audits each time a reimbursement request is received. When requesting reimbursement, subrecipients are required to submit client information, including eligibility and other demographics. Typically this is submitted in a summary form as well as copies of each client's application forms. The City staff undertakes audits of requests for payment by subrecipients to assure the address provided is within the city limits of Shawnee. In addition, verification is made as to the income qualification and the basis for the qualification by the subrecipient.

City staff continues to work with sub-recipients to ensure that any remaining funds are utilized, as well as work with all sub-recipients for compliance with program requirements and timely completion and reporting of activities.

The City of Shawnee CDBG program audit and monitoring procedures were updated during the 2018 program year. Remote desk reviews were completed in 2022.

All requests for bids for projects using CDBG funds are placed in the local Spanish language newspaper. All contracts refer to CDBG and City of Shawnee requirements that address minority business outreach.

The City of Shawnee sought citizen input in a variety of ways. The City's Citizen Participation Plan outlines the policies and procedures to receive input to identify the needs and to allocate CDBG funds.

Per Federal requirements, all entities which receive \$750,000 or more of Federal funds each fiscal year must submit a Single Audit. The City annually confirms with each subrecipient if the Federal funding threshold has been met, and submission of the Single Audit to the Federal Auditors Clearinghouse has been completed within nine months of the end of the applicable fiscal year. City staff reviews the audits to ensure CDBG funds received from the City of Shawnee have been reported, as well as reviews any findings. Staff confirms implementation of a corrective action plan relative to any findings. Shawnee did not meet the Federal threshold for requiring submission of a Single Audit in 2022 for the 2021 fiscal year. Shawnee's fiscal year is the same as the calendar year, so if required a Single Audit for 2022 must be submitted by October 1, 2023.

Citizen Participation Plan 91.105(d); 91.115(d)

Describe the efforts to provide citizens with reasonable notice and an opportunity to comment on performance reports.

On December 27, 2022 a public notice was published in the Legal Record newspaper and on the City's webdsite to provide notice of a public hearing to be held on January 23, 2023 for review of the 2022 CAPER. The public notice also included information about where to review the CAPER, the designated 20-day comment period, and how to provide any comments.

A public hearing was held by the Governing Body on January 23, 2023. There were no public comments made during the hearing. The advertised public comment period was January 24 through February 14, 2023. No public comments were received during that time.

Per the City's Citizen Participation Plan, all meetings and public hearings are held in locations accessible to people with disabilities. If any individual requires special accommodation (i.e., qualified interpreter, hearing assistance, etc.) or a non-English speaking individual requires a translator in order to participate in any meeting or public hearing, they are requested to notify the City staff or, for the hearing and speech impaired, at 1-800-766-3777 (TDD) no later than 48 hours prior to the scheduled commencement of the meeting or public hearing. As available, we can publish public notices in English and Spanish. We do have limited Spanish speaking staff on hand at City Hall that are able to translate if needed on-site.

The CDBG program requires a public hearing be held to provide the opportunity for citizen participation for review of the annual CDBG Action Plan and program performance. Staff will submit the report to the Department of Housing and Urban Development following the public hearing.

(a) Conduct the public hearing

MAYOR DISTLER: I will accept a motion to conduct a public hearing.

COUNCILMEMBER JENKINS: Move to conduct a public hearing.

COUNCILMEMBER CHALFIE: Second.

MAYOR DISTLER: A motion has been and seconded on this item. All those in favor

say aye.

COUNCILMEMBERS: Aye.

MAYOR DISTLER: Opposed nay. Motion passes.

MAYOR DISTLER: We are now in a public hearing. This is a formal public hearing required by law. Deputy Community Development Director Lauren Grashoff will have a brief presentation. Oh, you're up there. Welcome, Lauren.

MS. GRASHOFF: Good evening. Lauren Grashoff.

[2022 CDBG Annual Review - Program objectives slide]

I'm just going to do a very quick highlight of essentially our 2022 Annual Action Plan. This covers the full fiscal year of 2022. It is the third year under our five-year plan. Overall, the objectives we have for our Community Development Block Grant program include providing suitable living environments, decent housing, and economic opportunities.

[Program Priorities slide]

Within those broader objectives, and with your approval, identified priorities for use of these funds every year. They include non-housing community development, public facilities and infrastructure, housing rehabilitation, homelessness prevention, and public services. So, all of the activities that we carry out under each annual plan must meet both the objectives and those priorities that have been set within these plans.

[2022 CDBG Expenditures slide]

In 2022, we had a number of program expenditures. They included primarily our -- some of our public service providers, which do provide rent and utility assistance as well as childcare assistance. And then usually our biggest expenditure for the year is an infrastructure improvement project, which includes street and stormwater improvements. And this is the neighborhood 59th Street from King to Barton. And then Friends of JCDS also did a rehab project. It was roof and gutter repairs for a home that they own here in Shawnee that houses intellectually and developmentally disabled persons.

[Ongoing CDBG Projects slide]

We do have still a number of ongoing projects within the 2022 funding and other fiscal years. All of these are either in progress or actually were wrapped up after the first of the year. But this review is limited how HUD sort of frames it as literally from January 1 to December 31st though next year's plan will show a spend down of most of these items here. But these are just ongoing projects like I said that are either underway or have actually been wrapped up.

[CDBG-CV Expenditures slide]

Currently in 2020, we were awarded CDBG coronavirus monies. Under this, this was actually on our 2020 action plan. But since this is a program that has a four-year award timeline, I just wanted to give an update on some of those expenditures and ongoing un-obligated funds that we have for those monies.

Most of our public service monies have been allocated, at least that had committed sources. We had more emergency assistance payments for things like rent, utility, food. And then we also had two home rehab projects for friends of JCDS. And then our SERA grants, which were the Shawnee Economic Recovery Grants for small businesses that provided rent and mortgage assistance. That project was wrapped up this year and we spent just over \$143,000 on grants, awarding up to \$5,000, again, for that rent or mortgage assistance.

[Ongoing CDBG-CV Projects slide]

Some ongoing projects. We do have -- Salvation Army still has a little bit of money left. And these projects are directly to serve -- there has to be some sort of correlation to needs around the coronavirus. We do have undetermined. So, basically, we've kind of identified the purpose and outlined what these large amount, you see almost \$240,000 of activities that can be programmed for public service or public improvements. But we currently do not have specific projects for that money. We do have until September 21st, yes, of this year to spend at least 80 percent of all of our CDBG-CV grants. Currently we're right around 42 percent of our coronavirus monies have been spent.

At this time, we do not have any additional funds or expenditures programmed for these \$237,000. HUD has not said what they're going to do if we don't have that 80 percent expenditure by September of this year. They just have said the funds may be recaptured. But we are always looking for opportunities to get those programmed and work with our current service, sub-recipient grantees to make sure if there are any outstanding needs that these funds can be a source for them to utilize these.

[Next Steps slide]

So, next steps just include, following the public hearing this evening, there is a 20-day public comment period, which has already been noticed. That will go through February 14th. After that, that's when we do submit the annual report to HUD for their review and any comments that they have on that. So, that concludes my presentation.

MAYOR DISTLER: Councilmember Knappen.

COUNCILMEMBER KNAPPEN: Thank you, Lauren. Just two follow-up questions. Number one, on the 200, or on the Shawnee Economic Recovery grants, we spent 143,000 and something. You said in increments of 5,000. I was just curious how you would define a microenterprise. And then do we have folks actively coming to us, or are we going out and kind of marketing this, or letting folks know that this is available for the microenterprises?

MS. GRASHOFF: Yeah. So, microenterprise is actually defined by HUD in this instance. It's one to five -- a business that's one to five employees that one can be literally the owner of the business. If that businessowner is what we -- within the 80 percent of the area median income, they qualify for this microenterprise assistance. Anything beyond basically how we classified it after that was six employees to, what did we set the threshold? Somewhere -- I think it was a hundred employees might have been smaller than that, businesses and their owner wasn't -- didn't essentially fit within that microenterprise category. But they could say that they were going to retain a low to moderate income job. So, not necessarily a person but at least a position within their company. As a way, since they were using these funds, it would essentially offset employee costs. So, they just had to certify that they were having job retention as a result of receiving these funds.

The way we actually ran this program was we had a -- we've actually had two rounds of this. The first round we ended up using City monies because we had a lot of difficulties with getting businesses to qualify for this program. The second round, we reopened, I believe it was last spring, and we actually used some administration monies to help -- Community Capital Fund actually helped us administer this round. They have a lot more experience with doing grant underwriting, reviewing sort of business finances, which is not my speciality. So, we did actually have a lot of help with this. They went

out into the community and did outreach while this application period was underway. So, we did a lot more the second round with going out to businesses, talking to people, sending a variety of notices and outreach for that.

COUNCILMEMBER KNAPPEN: That's what I was wondering. You know, if, I don't, but say I owned a small doughnut shop, I mean, are we going in and letting them know that this might be available for them?

MS. GRASHOFF: Yes.

COUNCILMEMBER KNAPPEN: The second question I had, 237,000 is undetermined. And you said 80 percent of it has to be spent by September. Why wouldn't we go ahead and earmark that for a public improvement project on our CIP?

MS. GRASHOFF: So, it is something that we can do. Because we gave it sort of that broad purpose and scope, we can decide to program these within essentially any project that meets that criteria for essential public service or public improvement. It does it have to correlate though to prevent, prepare for, or respond to the coronavirus. So, that's something we would have to assess as we look at our CIP if there's some sort of correlation that we can draw there. But there is opportunity to program these funds and get these spent.

COUNCILMEMBER KNAPPEN: So, I assume you'll be looking to do that.

MS. GRASHOFF: Definitely will.

COUNCILMEMBER KNAPPEN: Thank you.

MAYOR DISTLER: Councilmember Thomas.

COUNCILMEMBER THOMAS: Thank you for that presentation, Lauren. You did a great job. I'm thinking of families that even I know of that are struggling, and perhaps a parent has had an emergency surgery. They don't know what they're going to do with the two kids they have, all that type of scenario. How does someone like that, who all they may need is support with childcare while they get back on their feet and recover from a, you know, whatever need they had. Is this an opportunity for them to gain support if they're a local citizen?

MS. GRASHOFF: So, with these monies, we actually don't ourselves offer the direct client services --

COUNCILMEMBER THOMAS: Uh-huh.

MS. GRASHOFF: -- since that's generally not something we provide as a city. But we do use our sub-grantees like Salvation Army, Catholic Charities, Metro Lutheran Ministries who do provide those services and connect them with those entities that do provide that.

COUNCILMEMBER THOMAS: Okay. I'd like those names so that I can share that.

MS. GRASHOFF: Yeah.

COUNCILMEMBER THOMAS: Thanks.

MAYOR DISTLER: Councilmember Gillette.

COUNCILMEMBER GILLETTE: Lauren, thanks for the presentation. Additionally, I know we have quarterly faith and community quarterly meetings. I know we have one coming up in I believe a week or so. Has there been any discussion at those quarterly meetings for ways to utilize percentage dollars that are left over? Or are we also looking at that meeting as a tool to try and --

MS. GRASHOFF: Yeah. That's definitely a good suggestion. I know some of the organizations that are involved in that -- those meetings do already -- are connected through various other United Community Services through other channels. But that's simply something that we can mention for sure.

COUNCILMEMBER GILLETTE: Great. I know there's other faith-based organizations that attend those quarterly meetings and maybe there's some opportunities there. So, great. Thank you.
