2023R/2024 Budget Focus

- Inflationary Costs
 - Higher costs associated with the majority of City expenses
 - Limited number of new requests or additions to budget
- Compensation Study
 - Higher costs across all personnel areas due to higher wages
- One-Time Expenditures
 - Facility Conservation Improvement Program (FCIP) Phase III
 - Initial Funding for the new Risk Management Fund
