You should be given a Shawnee Fire Department Observer Identification Badge upon arriving at the fire station. This badge shall be worn for the duration of your ride-along shift and returned as you leave.

As a reminder, the <u>maximum</u> ride-along shift length is: 9:00 a.m. to 5:00 p.m.
